### TERMS & CONDITIONS

#### PAYMENT POLICY

Deposit (outside of peak season)

- A 25% deposit is payable within fourteen (14) days from date of confirmation. The balance payable is due six (6) weeks prior to arrival.
- Should The Royal Portfolio receive a secondary enquiry against provisional/unconfirmed booking, we will endeavour to make contact with you. A response within 24 hours will be required failing which the rooms will be automatically released. If a response is received the initial enquiry will have seven (7) days to confirm or release.

Peak season

- The peak season at each property is as follows:

Royal Malewane and The Farmstead

- June, July and August
- 15 December to 15 January

Birkenhead House, La Residence, The Silo and Private Residences

- 15 December to 15 January

During peak season the following payment and cancellation policy applies:

- A 25% **non-refundable** and **non-transferable** deposit is payable within seven (7) days from date of confirmation.
- Full payment is due 4 months (120 days) prior to arrival for all bookings. If full payment is not received by the due date, the booking will unfortunately be cancelled and the deposit forfeited.
- Payment for accommodation can be made either via a direct wire transfer instruction or Electronic Funds Transfer (EFT).
- Payment for extras can be made at the hotels by cash, traveller's cheques, or either Visa/MasterCard/Amex or Diners Club cards.
- There is a 2% administration fee on all credit card transactions for accommodation charges.
- Payments must be made in South African Rand (ZAR) via wire transfer or EFT, NETT of bank charges.

#### CANCELLATION POLICY

Cancellation fees will be levied in the event of a cancellation and in accordance with the reservation terms and conditions of The Royal Portfolio.

- 5 % of accommodation as an admin fee if cancelled more than 12 weeks prior to arrival
- 25% of accommodation if cancelled 8 to 12 weeks prior to arrival
- 50% of accommodation if cancelled 4 to 8 weeks prior to arrival
- 100 % of accommodation if cancelled less than 4 weeks prior to arrival
- 100% of accommodation and pre-booked transfers for any 'no shows'

Please note that a change of date of a confirmed reservation constitutes a cancellation and the above cancellation fees apply.

#### TRAVEL INSURANCE:

The guest is obliged to ensure that he/she has taken out adequate travel insurance to cover the financial implications of The Royal Portfolio Cancellation Terms & Conditions. The Guest will bear the sole & absolute responsibility in this regard.

#### MINIMUM STAY

Please note that during high/peak/festive season we operate a dynamic minimum night stay policy whereby we will seek to accommodate any length of stay provided that the booking does not create an unsellable night.
